INTRODUCTION

ACTIVITIES HELD SINCE THE LAST MEETING

• 2 August 2006

Mrs Stella Lau, Member of the WoC, attended the Focus Group Discussion of "Family Education for Economically Disadvantaged and Hard-to-Reach Families" organised by the Chinese University of Hong Kong.

• 7 to 10 August 2006

The WoC Chairperson joined the HKSAR Team and attended, as part of the Chinese Delegation, the CEDAW hearing on the second report on HKSAR under CEDAW held in New York. The HKSAR Team was led by Ms Sandra Lee, Permanent Secretary for Health and Welfare, and comprised representatives of the relevant Government bureaux and departments.

• 12 August 2006

The press conference was hosted by the WoC Chairperson, Dr Yeung Ka-ching, Co-Convener of WoC's Working Group on Empowerment, Member of the WoC, Mr Ng Sui-kou and Mr Yip Hak-kwong of the Policy 21 Limited of the Hong Kong University.

The Conference on "Strengthening Hong Kong's 5 September 2006: Families - Awareness, Commitment and Action" was held at the Hong Kong Convention Exhibition Centre. The Conference co-organised by the WoC, the Central Policy Unit of the Government and the Family Institute of the Hong Kong University. Mr. Donald Tsang, the Chief Executive, officiated at the Opening Ceremony and gave a speech. Around 300 non-government organisations and participants attended and had good and vivid exchanges on a wide range of issues of concern to family.
