WOMEN'S COMMISSION Secretary's Report

INTRODUCTION

This paper informs Members of the activities undertaken by the Women's Commission (WoC) and Welfare Team 2 of the Labour and Welfare Bureau (LWB) since the 57th meeting held on 29 January 2010.

ACTIVITIES HELD SINCE THE LAST MEETING

- 2. The activities held since the last meeting are as follows -
 - 30 January : PAS(Welfare)2 officiated at the graduation ceremony 2010 for the women leaders jointly organised by Tsuen Wan District Council Social Service & Community Information Committee Working Group on Integrated Community Services and Tsuen Wan Kwai Ching District Women's Association.
 - 26 February : The WoC Chairperson and AS(Welfare)2C attended the 4 March 2010
 54th Session of the Commission on the Status of Women (CSW) held in New York as part of the Chinese delegation. They also attended the NGO Global Forum held right before the CSW.
 - 5 March 2010 : PAS(Welfare)2 attended the International Women's Day (IWD) 2010 Gala Lunch organised by the Women's Foundation.
 - 6 March 2010 : Dr Yeung Ka-ching officiated at an event entitled "Marking the 100th anniversary of IWD with a talk by Dr Lee Lok Sze and with the establishment of the Kowloon Women's Organisations Federation "Cultural Groups Committee" organised by Kowloon Women's Organisations Federation.

• 8 March 2010 : WoC held a luncheon talk on "Women's Participation – An Economic Development Imperative" to celebrate IWD. Over 300 guests participated. The WoC Chairperson; Mr Paul Tang, Permanent Secretary for Labour and Welfare (PSLW); and Ms Guo Li, Deputy Director, Liaison Office of the Central People's Government in the HKSARG officiated at the ceremony.

Speakers of the luncheon talk included the Hon. Leung Chun-ying, Convenor of the Non-official Members, Executive Council; Mrs Margaret Leung, Vice-Chairman and Chief Executive, Hang Seng Bank; and Ms Eirene Yeung, Director, Corporate Strategy Unit and Company Secretary, Cheung Kong (Holdings) Limited. Prof Richard Wong, Deputy Vice-Chancellor and Provost of the University of Hong Kong, was the commentator while Ms Ayesha Macpherson was the moderator of the luncheon talk.

A series of radio promotional programmes in connection with IWD was launched between 28 February and 13 March through Metro Radio, including a delay broadcast of the WoC luncheon talk and promos on women's economic participation.

The WoC Chairperson officiated at the cocktail reception celebrating the IWD organised by the Hong Kong Federation of Trade Unions Women Affairs Committee.
