目的

行政長官於《2020年施政報告》中宣布,由於2019年的社會事件,以及自2020年年初起持續的2019冠狀病毒病疫情,為市民的精神健康帶來不同程度的衝擊和影響,因此,政府決定在禁毒基金預留三億元,以協助在社區加強支援有需要人士,以及提高公眾對精神健康關注。精神健康諮詢委員會負責統籌這項資助計劃,並與相關業界的服務提供者及非政府機構合作,從而識別需要和訂定優次,以促進或推廣相關項目。

這項名為「精神健康項目資助計劃」分兩階段推出。 第一期「精神健康項目資助計劃」於2021年7月推出,邀請合 資格機構提交建議書,申請撥款推出精神健康項目。第二期 資助計劃的詳情將於2022年公布。

Carer Support

- To enhance support for carers, identify & intervene high-risk / hidden cases, address their psychological and emotional needs

IT Support for the Elderly

- Tertiary institutions registered under the laws of Hong Kong

A branch/ district/ subsidiary organisation / department <u>must</u> submit its application <u>via</u> its headquarters/ central organisation/ faculty by having the **Statement of Application** <u>signed off by the head of the headquarters/ central organisation/ faculty</u>

申請數目上限、可得撥款額及項目資助期 Maximum Number of Applications, Grant Receivable and Project Duration

Applicant organisation may submit proposal for project -

- (a) not exceeding \$500,000; or
- (b) exceeding \$500,000 but not exceeding \$2 million

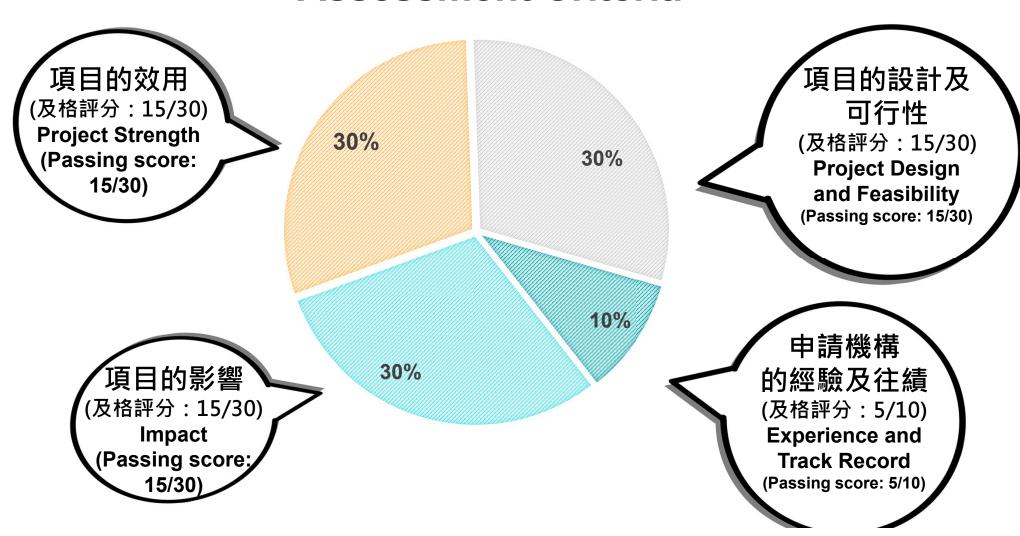

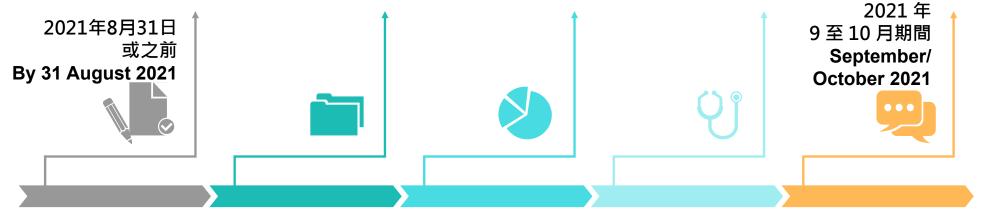
