## Consultancy Study on the Long-term Development of Child Care Services

#### **Purpose**

This paper briefs Members on the Consultancy Study on the Long-term Development of Child Care Services (the Study) commissioned by the Government, and seeks Members' view on the Study.

#### **Policy Objective**

2. In January 2015, the Government announced in "Population Policy: Strategies and Initiatives" and in the 2015 Policy Agenda the commissioning of a consultancy study to advise on the long-term development of child care services.

#### **Contents of the Study**

- (a) The Consulting Team
- 3. Through the established selection and approval procedures, the Social Welfare Department (SWD) commissioned the Study in December 2016 to a Consulting Team headed by Professor Paul Yip of the Department of Social Work and Social Administration of The University of Hong Kong. A Steering Committee on the Long-term Development of Child Care Services has also been set up for overseeing and monitoring the progress of the Study, as well as endorsing the work plan, the inception report, the interim report and the final report submitted by the Consulting Team during the Study period.

#### (b) *Objectives of the Study*

- 4. The Labour and Welfare Bureau (LWB) and the SWD consulted various stakeholders (including Legislative Council Members, The Hong Kong Council of Social Service, non-governmental organisations (NGOs) and service users) on the areas to be covered in the Study and other relevant matters. Besides, the SWD met with service operators, local organisations, women's groups, etc. at the working level to collect their views on the objectives and scope of the Study.
- 5. Having regard to the views of different parties, the Government decided that the Study would aim at further reviewing the demand and supply of child care services and make recommendations on the direction for the long-term development of such services. The objectives are as follows -
  - (i) to review the philosophy and policy objectives of day child care services;
  - (ii) to take stock of the operation modes and service positioning of day child care services;
  - (iii) to identify service gaps, to gauge the demand and supply of day child care services, and to explore a systematic and workable service planning mechanism; and
  - (iv) to advise on the service modes and financing modes of day child care services with reference to the needs of different types of families and other relevant considerations (including cost-effectiveness and sustainability, etc.).

#### (c) Scope of the Study

- 6. The Study will draw on the experience of places outside Hong Kong, take stock of the existing day child care services in Hong Kong, collect views from various stakeholders (including Government Bureaux/Departments, advisory bodies, concern groups, service users/potential service users, NGOs, local child care service operators, employers, etc.) and make recommendations on the long-term development of local child care services with reference to the findings of the Study, including -
  - (i) the service objectives, service contents, target user groups

- and planning parameters of aided standalone child care centres (CCCs) which are under the SWD's planning and regulatory control;
- (ii) the relationship between CCC service (including standalone CCCs and kindergarten-cum-CCCs) and kindergarten education;
- (iii) the manpower planning and training for child care staff (including child care workers and child care supervisors);
- (iv) the planning mechanism applicable to centre-based day child care services;
- (v) the functions of the Neighbourhood Support Child Care Project and the Mutual Help Child Care Centres, as well as the improvement measure to enhance the service quality and optimise the use of public resources;
- (vi) the appropriate service model(s) and financing mode(s) for different types of day child care services;
- (vii) the projection of the demand and supply of day child care services;
- (viii) the need for re-engineering and integrating different types of day child care services; and
- (ix) the role of the Government vis-à-vis private operators in the provision of day child care services.

#### (d) Work Plan and Inception Report

7. On 5 April 2017, the LWB and the SWD conducted an engagement session during which the Consulting Team briefed the service operators of various child care services, frontline staffs, parents, women's groups and professional bodies, etc. on the proposed work plan of the Study and collected the views from different parties. The Consulting Team then submitted a work plan, which was discussed and endorsed by the Steering Committee at its meeting on 4 May 2017. The SWD also received an inception report submitted by the Consulting Team on 13 June 2017. The Study comprises the following three main parts based on the contents of the inception report -

#### (i) Part I

By drawing reference to the experiences of Singapore, Australia, South Korea and Finland in providing child care services, the Consulting Team will conduct in-depth analyses and make recommendations on the objectives, contents, targets, financing modes, service models, demand and supply situation, facility planning, manpower planning and training, etc. of child care services in Hong Kong.

#### (ii) Part II

• Through population projection figures and the geo-spatial analysis technique, the Consulting Team will analyse the supply of day child care services in different districts, examine the service operation of existing child care services (including availability, accessibility and affordability), and makes integrated analyses.

#### (iii) Part III

- Through questionnaire-based survey and interviews with service users/potential users, frontline staffs, management and decision-makers, etc., the Consulting Team will solicit their views on the objectives, contents, targets, financing modes, service models, demand and supply situation, facility planning, manpower planning and training etc. of child care services in Hong Kong, and make in-depth analyses.
- 8. Lastly, the Consulting Team will consolidate the findings collected from the above three parts for making a comprehensive detailed analysis, and formulate recommendations in respect of the long-term development of child care services.

#### **Expected Timeframe**

9. The SWD expects that the Study will take at least one year to complete.

#### **Advice Sought**

10. Members are invited to note the contents of this paper and express views.

# 研究目標



- 1. 檢視日間幼兒照顧服務的理念和政策方針 to make observations on the philosophy and policy objectives of day child care services
- 2. 總結日間幼兒照顧服務的運作模式和服務定位 to take stock the modes of operation and positioning of day child care services with reference to the demographic changes after the harmonization of pre-primary services and other relevant considerations
- 3. 辨識服務斷層,評估日間幼兒照顧服務的需要和供應情況及制定一個具系統及可行的機制 to identify service gap, to gauge the demand and supply of day child care services, and to explore a systematic and workable planning mechanism
- 4. 透過參考不同類型家庭的需要及其他相關考慮因素,從而對不同日間幼兒照顧服務的服務模式和資助模式/財務方向提供建議to advice on the service modes and the financing modes of day child care services with reference to the needs of different types of families, and other relevant considerations including cost-effectiveness and sustainability etc.

1. 社會福利署規劃和監管的獨立幼兒中心的服務宗旨,服務內容,服務使用 群體及規劃參數;

the service objectives, service contents, target user groups and planning parameters of aided standalone child care centres (CCCs) which are under the planning and regulatory control of SWD;

2. 幼兒中心服務包括獨立幼兒中心及幼稚園暨幼兒中心,與幼稚園教育的關係;

the relationship of CCC service, including standalone CCCs and KG-cum-CCCs, with kindergarten education;

- 3. 幼兒中心工作人員(包括幼兒工作員及幼兒中心主管)的人手規劃及培訓; the manpower planning and training for child care staff, including child care workers and child care supervisors;
- 4. 切合中心為本幼兒照顧服務的規劃機制; the appropriate planning mechanism for centre-based day child care services;
- 5. 鄰里支援幼兒照顧計劃(NSCCP)及互助幼兒中心(MHCCC)的功能,提高服務質素及善用公共資源的改善方案;

the functions of the Neighbourhood Support Child Care Project (NSCCP) and mutual help child care centres (MHCCCs) and proposed changes to enhance the service quality and optimise the use of public resources;



- 6. 不同類型的日間幼兒照顧服務的適用服務模式和資助模式; the appropriate service model(s) and financing mode(s) for different types of day child care services;
- 7. 推算日間幼兒照顧服務的需要和供應情況;
  the projection of the demand and supply of day child care services including government-subsidised and non-government-subsidised services, as well as the ancillary services, i.e. Extended Hours Service (EHS) and Occasional Child Care Service (OCCS) in the territory;
- 8. 重整並綜合各類型的日間幼兒照顧服務的需要; the need for re-engineering and integration of different types of day child care services;
- 9. 政府及私營機構在提供日間幼兒照顧服務方面的角色。 the role of Government vis-à-vis the private market in the provision of day child care services.






